Focus on Antipsychotics and Dementia Training

The most recent data released by the Partnership to Improve Dementia In Nursing Homes once again ranks Louisiana as the state with the highest prevalence of antipsychotic use for long-stay residents. In view of the decision by CMS to include new measures to the Five Star Quality Measures, both measuring the use of antipsychotic drugs, it is more important than ever to focus on this issue within our facilities. During the recent LNHA Education Committee Meeting, DHH representatives reported that they are planning to contact nursing facilities with high antipsychotic drug use and, on a voluntary basis, offer to provide assistance. As a reminder, LNHA has offered, and will continue to offer, workshops and conferences that include dementia training.

In 2012, CMS issued S & C: 12-44-NH "Hand in Hand: A Training Series for Nursing Homes, on Person-Centered Care of Persons with Dementia and Prevention of Abuse" which was revised in October of that year. (cont. on page 2)

Focus on Antipsychotics and Dementia Training (Cont.)

CMS announced that the training program was designed to meet the annual nurse aide training on the subjects of dementia and abuse (<http://www.cms.gov/Medicare/Provider-Enrollment-and-Certification/SurveyCertificationGenInfo/Downloads/Survey-and-Cert-Letter-12-44.pdf>). The training, titled, "Hand in Hand" contained an orientation guide, six-one hour video-based modules, as well as an accompanying instructor guide. DHH provided the toolkit to all the nursing facilities in the state free-of-charge. There are no additional copies available at DHH, however, it is possible to request a download from CMS for training purposes. The download is available at <http://www.cms-handinhandtoolkit.info/Downloads.aspx>. Section 6121 of the Affordable Care Act requires providers to ensure that nurse aides annually receive this training and surveyors will be looking to see that it has occurred. In addition, please remember that state law also requires dementia training for all staff. The state regulations can be found in the Louisiana Register, Volume. 35, Number 08, August 20, 2009 which is available on the Division of Administration website, <http://doa.louisiana.gov/doa/>.

Conversations Change Lives: LaPOST Coalition Promotes National Healthcare Decisions Day



On April 16, the Louisiana Health Care Quality Forum, on behalf of the Louisiana Physician Orders for Scope of Treatment (LaPOST) Coalition, will join hundreds of health care-related organizations across the country in support of National Healthcare Decisions Day (NHDD), a nationwide initiative focused on increasing awareness about advance care planning.

Despite gains in advance care planning education, a recent Pew Research Center study found that while 95 percent of Americans had heard of a ‘living will,’ or advance directive, only 29 percent had completed one. Further, according to research by the Agency for Healthcare Research and Quality (AHRQ), 76 percent of physicians whose patients did have an advance directive were not aware that it existed.

“These are statistics that we seek to change in our state,” says Susan Nelson, MD, Chair of the LaPOST Coalition. “We have a shared goal with our NHDD partners: to improve these numbers by inspiring, educating and empowering the public and health care providers with information about the value of advance care planning and available advance care planning options.”

In Louisiana, those options include documents such as the advance directive, also known as a living will, and the health care power of attorney. A living will is typically written well in advance of any known illness and describes the type of care a patient wants if something occurs, particularly scenarios in which the patient does not wish to receive aggressive medical care. Unfortunately, less than 25 percent of Americans have this level of planning, and even with an advance directive in place, the document requires interpretation and a physician’s order before it can be implemented.

The health care power of attorney document identifies the person who makes health care decisions if the patient becomes unable to do so, and requires the patient to state the kinds of decisions this person would make. If a health care power of attorney is unavailable, the state stipulates who would make those decisions – those individuals are, in order, a legal guardian (if one has been appointed); spouse (unless legally separated); the majority of children; parents; the majority of siblings; antecedents/descendants; special friends; and the attending physician (under certain circumstances).

Louisiana also has an advance care planning document designed specifically for patients with serious, advanced illnesses. The LaPOST document is more than an advance directive or health care power of attorney. It’s a medical order that is completed only after the patient - or the patient’s health care representatives - have discussed the patient’s goals of care and treatment preferences with his or her physician. LaPOST is completely voluntary, is biased neither for nor against treatment and can be modified or revoked at any time based on new information or a change in the patient’s condition or wishes. As a medical order, it travels with the patient across health care settings. When completed, it must be followed by all health care professionals. The LaPOST document may also be used to translate an advance directive into a physician’s order.

“Most importantly, it requires patients and caregivers to have real conversations about treatment options when a cure is no longer possible,” Nelson says. “These can be difficult conversations to have, but by discussing treatment options and personal goals, values and beliefs, patients can make their final days the best possible for themselves and their loved ones.”

Nelson notes that multiple studies have shown that patients and families who discuss their wishes for end-of-life care actually receive better care that’s patient-centered and in a location they want, whether it’s at home, in a hospital or nursing facility or elsewhere. Through advance care planning documents like LaPOST, she says, “Patients can design treatment strategies that ensure that the care they receive matches the care they want.”

“It’s a conversation that can be uncomfortable, but without it, the patient’s family or caregiver may never know what the patient’s wishes were, and he or she may not receive the kind of care that was wanted at the end of life,” she explains. “Families that have advance care planning documents like LaPOST in place find it easier to make those decisions because they know exactly what was wanted at the end of life. LaPOST provides patients with a voice to make those wishes heard and to make sure they are honored.” (cont. on page 4)

“While the LaPOST document is specific to patients with serious, advanced illness, advance care planning is a gift every patient, regardless of age or health, can give themselves and their loved ones,” Nelson adds. “We want everyone to have that important conversation on National Healthcare Decisions Day.”

To assist Louisiana’s patients and families in developing advance care plans and discussing their end-of-life care wishes, the LaPOST Coalition developed a special guidebook, “[Conversations Change Lives](#).” The guidebook may be viewed and downloaded from the LaPOST [website](#). The website features a number of other advance care planning tools for patients and families, and it also provides several advance care planning educational resources for health care professionals.
